 - The event must have a substantial FIPA "flavour"
 - FIPA must be offered the opportunity to have FIPA speaker
 - FIPA members must be offered a discount of at least 10% for attendance
 - No conflict with a scheduled meeting of FIPA
 - The FIPA logo must be used on all material related to the event.
- The establishment of a policy for the award/remuneration to students for making a contribution to FIPA (fipa9118).
- The instruction to be given to the Secretariat about members that have not paid their 1998-99 membership fees. The list of delinquent members is given in fipa9111. Those members will receive a letter requesting the payment of their dues. They will be reminded that, according to article 4.6 of the FIPA Statutes, non payment of membership fees will lead to expulsion and that the delay for new Membership application is at least one (1) year form the date of expulsion.
- Appreciation to W. Bouma in maintaining the SIG site.
- The President will invite W3C and possibly OMG representatives to the Paris meeting.
